

**NOTICE TO BIDDERS  
FOR THE CONSTRUCTION OF  
PERIMETER FENCE REPLACEMENT  
AT THE  
CATTARAUGUS COUNTY-OLEAN AIRPORT

Sealed proposals for the construction of Perimeter Fence Replacement Contract will be received at the City of Olean Municipal Building, Department of Public Works, 101 East State Street, Olean, New York 14760 until 2:00pm, local time, June 16, 2016, and there, at said office, at said time, publicly opened and read aloud.

Base Bid: This project generally consists of the removal of approximately 1,000 feet of chain link fence, 8,000 feet of welded wire fabric fence and installation of approximately 9,500 linear feet of 8-foot tall chain link fence with 3 strands of barb wire. In addition, the project will include required clearing and grubbing of the fence line along with 4 double swing gates.

Add-On No. 1: This project generally consists of the removal of approximately 1,000 feet of welded wire fabric fence and installation of approximately 1,000 linear feet of 8-foot tall chain link fence with 3 strands of barb wire. In addition, the project will include required clearing and grubbing of the fence line.

Add-On-No. 2: This project generally consists of the removal of approximately 1,500 feet of welded wire fabric fence and installation of approximately 1,500 linear feet of 8-foot tall chain link fence with 3 strands of barb wire. In addition, the project will include required clearing and grubbing of the fence line.

The Contract Documents (consisting of the Advertisement, the Proposal, the Contract Form, and the Specifications) and the Contract Drawings may be obtained only from the City of Olean Municipal Building, Department of Public Works, 101 East State Street, Olean, NY 14760, telephone (716) 376-5650, upon deposit of fifty dollars (\$50.00) per set (check only), payable to the City of Olean. Any Contract Document holder, upon returning the Contract Documents in good condition within thirty (30) days of the award of contract, or rejection of proposals, will be refunded the full amount of his/her deposit. Parties failing to conform to the above conditions within the prescribed allotted time shall forfeit their deposits as heretofore set forth and shall have no recourse against the City of Olean for a refund of the Contract Documents deposit. Copies of the above described Contract Documents may be examined at no expense at the City of Olean Municipal Building, Department of Public Works and at C&S Engineers, 499 Col. Eileen Collins Boulevard, Syracuse, New York 13212.

Each proposal must be accompanied by a certified check or bid bond, in the amount of five percent (5%) of the total maximum proposal price (combination of base bid or alternate bid plus add-on items) for the contract in the form and subject to the conditions provided in the Preparation of Proposal.

A pre-bid conference has been scheduled in order to review the specific requirements of this contract. All prospective bidders are encouraged to attend. **The pre-bid conference is scheduled for June 7, 2016, at 11:00am at the Cattaraugus County-Olean Airport Terminal Building.**
