The City of Olean is requesting proposals to operate fixed route deviation services, which will be discussed below.

- Existing third-party contract to operate OATS awarded in 2020
 - Base year June 1, 2020 May 31, 2021
 - o Three one-year options awarded annually.
 - Transdev US, formerly First Transit, a division of First Group
 - Contract expires on May 31, 2024

OATS is sponsored by the City of Olean

- Recipient STOA and FTA section 5311 funding
- State and federal subsidies alone do not finance the transit operation
- OATS is a partnered system
 - o "Permanent" partners include
 - Intandem, Inc.
 - St. Bonaventure University
 - Seneca Nation of Indians
 - City of Salamanca
 - Cattaraugus County Department of Social Services
- Cost efficiency by coordinating service needs
 - o fixed route deviation services provided by the City via the OATS bus
 - o cost savings by coordinating services versus independent contracting or services
- Award of Transit Services
 - Affordability
 - Proposed hourly rates
 - Projected availability of grantor funding
 - Available OATS partner shares
 - Contingent upon continuation of partnering agreements
 - As a financial partnered system, Olean needs partner shares to pay for the services

The Public Notice of the Availability of the OATS Request for Proposals was advertised in local media, by the New York State Contract Reporter, by the New York Public Transit Association, and by Transit Talent, a transit industry newsletter.

 - The white body is a requirement imposed by NYSDOT vehicle inspectors to eliminate confusion with yellow school buses

- another color will be evaluated
- If a contractor-owned 52-60 passenger school bus style vehicle is proposed as a back-up vehicle, the body color should be painted white
 - Any alternative body color should be identified and will be evaluated
- Contractor-owned buses may not be accessible or wheelchair equipped
 - If buses proposed for service are not wheelchair equipped accessible
 - Consistent with OATS paratransit policy
 - Wheelchair equipped vehicle must be made available for service when requested
- List of contractor-owned vehicles and condition thereof shall be provided in response to RFP and will be evaluated
- o For the vehicles used in service, the contractor shall be responsible for:
 - fueling,
 - maintenance and repairs,
 - cleaning,
 - inspections,
 - storage,
 - insurance,

 - Contractor will provide the maintenance facility to perform these functions.

 - 3. Cost of Providing Services under Agreement, 15 points
 - 4. Financial stability and capabilities of Contractor, 15 points
 - 5. Availability and condition of contractor-owned buses to supplement City-owned buses, 10 points
 - 6. Maintenance record and facilities to maintain and store vehicles owned and provided by the City of Olean, 10 points
 - 7. Ideas to enhance delivery of safe, efficient fixed route deviation service operations, 5 points
 - 8. Plans to effect a smooth transition from current operations, 5 points

 Total 100 points
- Cost is a factor
 - This is not a low bid procurement
 - o Cost is one of the factors that will be evaluated to select the successful response to the RFP
