A Regular Meeting of the Olean Common Council of the City of Olean was held on Tuesday, March 25, 2025 at 6:30 p.m.

READING, CORRECTING & APPROVAL OF THE MINUTES OF THE PREVIOUS REGULAR MEETING

PUBLIC COMMENT/INPUT

A motion to amend the time limit for public comment from five minutes to three was made by Alderman Crawford, seconded by Alderman Robinson. Voice vote, ayes all. Motion carried.

Nate Smith of 1214 Irving Parkway read into the record a letter sent to the Mayor and Aldermen:

"Dear Mayor Aiello, Aldermen and Ms. Kerper,

I am reaching out regarding the West State reconstruction project. It sounds like not much is happening, but these projects have a way of springing to life. I have seen two versions of the project and both versions contain a center-street impediment to the driveway of our 96-year-old family business Worth W. Smith Co. (1624 West State St.). These impediments, whether they are a median or pedestrian island, would prevent east-bound traffic from entering our driveway entrance on West State St. We receive two to five tractor trailers per day and many of our customers have large vehicles and trailers. This inconvenience would be devastating, probably lethal, to our business. One could argue that trucks could enter from Washington Street, but trying to convey this to every truck delivery would be a nightmare (really impossible) and does the City of Olean really want two to five tractor trailers per day traversing Olean's side streets (right in front of an elementary school on Washington St.)? I believe West State Street is a designated truck route. Hence, the street should be designed to accommodate, not hamper, truck traffic.

Another worry: Roundabouts will be smaller than the ones on North Union due to the narrower street width. Roundabouts on West State will probably resemble the one at the intersection of East State and Barry Street; a very tight radius and not truck-friendly. If east-bound trucks cannot turn into our driveway on West State Street, they probably won't be able to make a 360-degree rotation at the next roundabout due to the small radius. East-bound trucks would have to travel all the way to the intersection of West State and Union to reverse direction. This would be a confusing, inconvenient, and unreasonable transportation model. There are other businesses on West State that

also receive regular truck traffic. This project and the center-street obstructions will be a concern for them as well.

I urge you not to underestimate the impact of projects like these on businesses. We live in a world of hyper-competition and consumers have lots of choices. When I stated that a center-street obstruction would be lethal to our business, I'm not being dramatic, just realistic. Please keep me in the loop if there are any developments or meetings regarding any aspect of the West State project.

Tom Morgan of 1721 West Fall Road explained he has been dealing with Code Enforcement to get a property cleaned up, but he feels they have not done anything to remedy this situation. He explained he wants to know why nothing has been done and explained if they aren't doing their jobs, they should be let go. He explained he is very frustrated and it should not take years to get this cleaned up.

Lynn Sachowicz of Conewango Valley explained she is here to support the solution to the sewage dumped into the Allegheny River. She explained she feels the PL introduced tonight looks like a reactionary move rather than a well thought out comprehensive plan. She explained Mr. Camp explained a majority of the issues are on private property but if we have homes disconnected from the sanitary sewer for the roof drains and water flows into a catch basin that is not properly routed into the storm sewer, then nothing improves.

Glen Wahl of Little Valley explained he is upset the public comment limit was shortened from 5 minutes to 3 minutes at the last minute. He explained he feels the Mayor's administration is doing a poor job providing requested documentation and he will be forced to file a FOIL request. He explained he does not feel the City cares about transparency or communication.

Mark Alessi of Conewango Valley explained he has spent much of his time in the river downstream from here and he is concerned about what Olean is doing to the river. He thanked the Council for doing the people's business as he knows it is not always appreciated, and he hopes the Council does the right thing. He explained the issues of the discharges into the river have an effect on the area's reputation and this affects the economy, which affects everyone.

Jessica Davis of North Olean explained she is concerned that the last water report online is from 2020. She explained she purchased a special filter for her shower and her children's skin issues have gotten better. She expressed concern about the quality of the water in the City as well as the price of water bills.

Tina Abrams, a Tribal Councillor for the Seneca Nation of Indians, urged the City to reach out to the DEC in Albany to assist with a fix for the sewage discharge issue. She thanked the Mayor for reaching out and scheduling a meeting with President Seneca. She explained there are many options for grants and they are offering their assistance with grant writing to help obtain these to fix the issue.

Klint Nephew, a Tribal Councillor with the Seneca Nation of Indians, explained they took a trip to Albany and learned a lot about the recovery help Olean can obtain from the DEC. He explained he is glad the Mayor reached out and will be meeting with President Seneca. He explained the Seneca Nation is extending out their hand to help, but Olean needs to accept it.

Justin Cashmere of North Olean explained he feels he has GI issues due to the water quality in Olean. He explained we are driving people out of Olean and no one will

move here because people know Olean does not care about its residents. He explained Olean needs to do better.

Carlos Andres of Jamestown asked the Mayor if he drinks from the faucet at his home. Alderman Crawford noted public comment is not for Q&A.

Erin Boyd of Frewsburg explained she is really disappointed and devastated reflecting on the past two weeks after learning about the wastewater issue. She asked what has been done and explained there is no information or updates on the City's website. She explained she doesn't understand how the City could allow kids to grow up with this issue, and the City needs to do something to fix it.

A member of the Seneca Nation of Indians expressed his disappointment in the City and the Mayor for not doing anything about the wastewater issue. He encouraged the Mayor and the City to step up and fulfil their obligations. He expressed people who don't do their jobs get fired and someone should step up that will take over and do what needs to be done.

WHEREAS, the SPCA has presented a contract to the City of Olean for services related to animal cruelty cases and animal control for dogs; and

WHEREAS, services for cruelty cases are for holding dogs for any matter in which the City will be pursuing cruelty charges for a per diem holding fee of \$15 per day, plus reimbursement for all reasonable and necessary medical expenses associated with treating such animal; and

WHEREAS, services for animal control for lost, stray, and abandoned dogs are for a cost of \$15 per day for the first five days and a cost of \$150 for transfer of ownership of the dog to the SPCA to allow the SPCA to adopt out the dog and/or make other disposition of the dog as it seems fit, at which point the City of Olean shall have no further monetary responsibility of the dog; and

RESOLVED, that the Common Council authorizes the Mayor to enter into an agreement between the City of Olean and the Cattaraugus County SPCA for services related to animal cruelty cases and animal control for lost, stray, and abandoned dogs within the City of Olean, to be billed to the City based on actual services performed.

RESOLVED, that this Resolution is hereby effective immediately. **ROLL CALL, AYES ALL. MOTION CARRIED.**
